

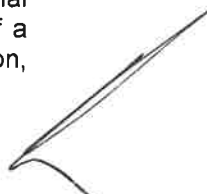
7. **REQUESTS FOR ACCESS TO RECORDS**

Requests for access to the records available for inspection, or other relevant information must be made in the prescribed form (Form C of Annexure B to the Regulations to the Act, a copy of which is annexed hereto) together with the request fee (if applicable) to the Group Legal Counsel by hand delivery to c/o Illovo Sugar Limited, 1 Montgomery Drive, Mount Edgecombe, Durban (at which address a copy of this Manual is available for inspection), or by mail at c/o Illovo Sugar Limited, PO Box 194, Durban, 4000, or by email to jmcintosh@illovo.co.za

The form must provide sufficient particulars to enable the head of the Company to identify the record/s requested and to identify the requester, indicate which form of access is required, specify a postal address or fax number of the requester in the Republic, identify the right that the requester is seeking to exercise or protect, and provide an explanation of why the requested record is required for the exercise or protection of that right. If in addition to a written reply, the requester wishes to be informed of the decision on the request in any other manner, the requester must state that manner and the necessary particulars to be informed in the other manner. If the request is made on behalf of another person, the requester must submit proof of the capacity in which the requester is making the request to the reasonable satisfaction of the head of the Company.

FEES

A requester who seeks access to a record containing personal information about that requester, is not required to pay the request fee. Every other requester, who is not a personal requester, must pay the required request fee of R50,00 (Fifty Rand) plus VAT thereon. If a request is granted then a further access fee must be paid for the search, reproduction,



preparation and for any time that has exceeded the prescribed hours to search and prepare the record for disclosure. The fees for reproduction of documents / information are those referred to in regulation 11 of the Regulations to the Act.
